Dear Parent/Carer

In April 2017 a team of inspectors from Education Scotland visited Wester Cleddens Primary School. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff. We gathered evidence to evaluate the quality of leadership and management, learning provision and children's successes and achievements.

The inspection team found the following strengths in the school's work:

- The leadership, drive and unswerving personal commitment of the headteacher to ensuring the very best for children.
- The sense of community and common purpose across the school encouraged by staff who work very well as a team to create a positive ethos and stimulating learning environment.
- Courteous, respectful children who have a positive attitude to learning.
- Highly effective approaches to inclusion, wellbeing and equality that result in children feeling very well supported and able to achieve.

The following areas for improvement were identified and discussed with the headteacher and a representative from East Dunbartonshire Council:

- Ensure all children are provided with appropriately challenging learning activities across the curriculum.
- Continue to improve approaches to assessing progress and raising attainment.
